RS3 CONTRACT OVERVIEW

The RS3 multiple award Indefinite-Delivery Indefinite-Quantity (IDIQ) contract is to provide Army Contracting Command - Aberdeen Proving Ground (ACC-APG) customers, other Program Executive Offices (PEOs), other Department of Defense (DoD) agencies, and other Federal agencies with knowledge-based support services for requirements with Command, Control, Communications, Computers, Intelligence, Surveillance, and Reconnaissance (C4ISR) related needs.

The spectrum of mission areas for programs with C4ISR-related requirements include such support services as Engineering; Research, Development, Test and Evaluation (RDT&E); Logistics; Acquisition and Strategic Planning; and Education and Training.
