The NETCENTS-2 family of contracts provides highly flexible contract vehicles delivering capabilities across the entire range of communications, networking, and telephony

product and service domains. It is the follow-on vehicle replacing NETCENTS. Smartronix was chosen as 1 of 17 awardees for the NETCENTS-2 NetOps Small Business Contract.

### Features

- Supports the following efforts:
  - Network Management and Network Defense
  - Service Oriented Architecture (SOA)
  - Enterprise Level Security/Management and Implementation/Operations
  - Telephone Infrastructure & Services
- *Stated as **the** contract vehicle for procuring cloud services by the USAF*
- Supports all Federal Agencies without restrictions
- Centralized contract administered by AFPEO BES w/decentralized ordering through AFWay (Central Website)
  - Allows local Contracting Officers to use their local processes for order execution and life-cycle management of their respective orders
- Supports all types of funding and various contract types (e.g., fixed-price, cost-reimbursement, labor-hour cost)
- \$5.8B ceiling and a 3-year base period and four 1-year option periods

Use of the NETCENTS-2 contracts (except ITPS) is mandatory for Air Force organizations but can be used by other DoD and Federal agencies. There are five contract 'buckets' with seven contract vehicles. Smartronix is a prime for the NetOps & Infrastructure Solutions Small Business Contract.
